The following decisions were taken in the meeting:-

In respect of PHE Department, 221 Projects were approved for funding by Jammu & Kashmir Infrastructure Development Finance Corporation (JKIDFC) Ltd for an estimated balance cost of ₹ 458.42 crore. For the remaining Projects which either lack Accord of Administrative Approval or exhibit zero expenditure as on date, it was decided that the Department shall complete the required formalities so that these projects could be considered for funding by JKIDFC Ltd. in the subsequent meeting.
- 6. In respect of languishing projects of PW(R&B) Department, nine (9) number of projects have been received back which had been returned for completion of the requisite formalities and stand now approved for funding through JKIDFC Ltd. against an estimated/balance cost of ₹ 19.59 crore.
- 7. Out of the projects submitted by Tourism Department, six (6) number of Projects stand approved for funding through JKIDFC Ltd. against an estimated/balance cost of ₹ 65.38 crore.
- 8. The Industries & Commerce Department submitted 31 number of projects for funding which stand approved at an estimated/ balance cost of ₹ 178.61 crore.
- 9. In respect of languishing projects of Health & Medical Education Department, 47 number of projects have been approved for funding by through Jammu & Kashmir Infrastructure Development Finance Corporation (JKIDFC) Ltd for an estimated cost of ₹ 90.53 crore.
