With a view to ensure effective real-time monitoring of the projects being implemented by the Jammu and Kashmir Infrastructure Development Finance Corporation, a Geotagging facility has been created in the J&K Infrastructure Monitoring System (JKIMS) Portal. Following has to be adhered by all concerned.

- 1. The Nodal Officers shall now onwards have to take photographs either online or offline mode through the JKIMS portal. The photographs which will generate date stamp and location shall only be entertained with the invoices being generated by the Nodal Officers. All the Nodal Officers shall have to make certain that no invoices are generated without ensuring that the photographs taken either in online mode or offline mode are uploaded on the JKIMS portal with date stamp and automatically generated location stamp.
- 2. The PIAs of the Departments implementing languishing projects shall in no case forward the invoices without ensuring that the photographs are uploaded in the manner prescribed to get real-time picture of the work done at the time of generating the invoices.

3. All the Administrative Secretaries are advised to ensure Geotagging of all the projects being implemented by the JKIDFC with the help of this embedded technological intervention in the JKIMS portal.
